SUMMARY ANNUAL REPORT

For

Northwest Ironworkers Health and Security Plan

We furnish this report to inform you of the financial activity of the **Northwest Ironworkers Health and Security Plan** and to assist you in better understanding how your Plan operates.

We caution you that not every participant receives benefits under all of these plans.

This is a summary of the annual report for the Northwest Ironworkers Health and Security Plan, (Employer Identification No. 91-6068079, Plan No. 501) for the period July 1, 2019 to June 30, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$44,947,456 as of June 30, 2020, compared to \$38,133,542 as of July 1, 2019. During the plan year the plan experienced an increase in its assets of \$6,813,914. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$53,143,357. This income included employer contributions of \$46,019,420, employee contributions of \$4,624,097, realized gains of \$86,569 from the sale of assets, and earnings from investments of \$2,100,106. Plan expenses were \$46,329,443. These expenses included \$3,411,145 in administrative expenses and \$42,918,298 in benefits paid to participants and beneficiaries.
